Sub: VE Commercial Vehicles Limited acquisition of Buses Business of Volvo Group India Pvt. Ltd.

TO WHOMSOEVER IT MAY CONCERN

Volvo Buses has played an active role in the modernization of the bus industry and public transport landscape in India since 2001. Over the years we have introduced several concepts and technologies that have established new benchmarks in terms of comfort, safety and performance. As a next step, Volvo's Management has decided to transfer the Bus Business in India to our Joint Venture Company i.e., VE Commercial Vehicles Limited (VECV) with effect from 1st October 2020. With this change, Volvo Buses will continue it's operations as a part of VECV instead of being a part of Volvo Group India Pvt. Ltd..

Pursuant to this decision, Volvo Group India Private Limited has entered into a Business Transfer Agreement on August 12, 2020 ("BTA") with VE Commercial Vehicles Limited ("Acquirer"). Pursuant to the BTA, the Bus Business of the Volvo Group India Private Limited that undertakes the production, marketing and sale of buses and coaches in India including land and building and machine of such Bus Division, located at Yalachahalli, Hosakote Taluk, Tavarekere Post, Bengaluru, Karnataka – 562122, shall be transferred to the Acquirer. As a part of the BTA, Business Contracts, the permits, consents, approvals, licenses etc. relating to the Bus Business shall also to be transferred to the Acquirer. The acquisition of Bus Business of Volvo Group India Private Limited shall be effective from 1st October 2020. The said acquisition would require changes at your end in terms of invoicing and communication that would reflect the new entity. In order to ensure a seamless transition, please take a note of the following information:
